## Union Free High School Election

Mr. M. W. Showers,  
Mazomanie, Wisconsin.

My dear Mr. Showers:

The statute provides that the annual election for union free high schools shall be held on the last Monday in June unless that be a legal holiday, in which case the election is to be held the following day. The polls are to be open from 1 o'clock p. m. to 7 p. m. and the law provides that the election shall be held at some convenient place and that the time and place shall be designated on the notice of the annual election. Immediately after the close of the polls the votes shall be counted to determine the results of the election. Immediately after the canvass of the votes the annual meeting of the union free high school shall be called to order for the transaction of such business other than the election of officers as may legally come before the meeting.

The officers to conduct the election of the union free high school district are the district clerk and two other persons selected by the district board. In case an incorporated village is included in the district, one of the officers chosen to assist the district clerk shall be selected from the village and one from the territory lying outside the village within the union free high school district. The compensation to be paid to the inspectors and clerks of any annual or special meeting shall be fixed by the district board but shall not exceed \$2.00 for each inspector. This compensation shall be paid from the district treasury.

The law requires that the district clerk shall give at least six days' previous notice of the annual meeting by posting a notice thereof in six or more public places of the district, one of which shall be fixed to the outer door of the union free high school building. Yours truly,

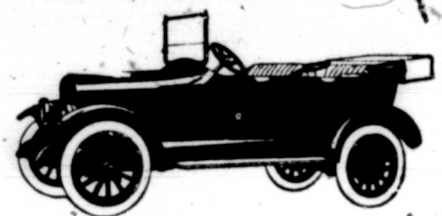
